



MEMORANDUM OF UNDERSTANDING FOR ACADEMIC COLLABORATION

BETWEEN

DR. B.R. AMBEDKAR, GOVT. COLLEGE, DABWALI

And

GOVT. COLLEGE FOR GIRLS, KALANWALI (SIRSA)

This agreement is made on this 07th day of February, 2023, between **Dr. Bhim Rao Ambedkar, Govt. College, Dabwali** herein after referred to as "**Dr. B.R.A. G.C. Dabwali**", which expression shall, unless excluded by or repugnant to the context, be deemed to include its successors in office and assignees of the first party and **Govt. College for Girls, Kalanwali (Sirsa)** hereinafter referred to as "**GCG, Kalanwali**" which expression shall, unless excluded by or repugnant to the context, be deemed to include its successors in office and assignees of the second party.

Whereas Dr. B.R. Ambedkar, Govt. College, Dabwali is a premier multi-faculty co-educational institution of Higher Studies situated Sirsa road, Dabwali and was established on June 2007 and affiliated to Ch. Devi Lal University Sirsa. Presently it has student strength of approx. 1000.

And WHEREAS the **Govt. College for Girls, Kalanwali** established in the year 2018, affiliated to Ch. Devi Lal University, Sirsa, situated at Village Taruana, Rori Road, Kalanwali is also a premier multi-faculty institution of Higher Studies with current student strength of approx 375.

Whereas both the parties has shown their desire to enter into this Memorandum of Understanding (MoU) so that it could prove to be mutually beneficial to both the parties that allows for panoramic sharing of resource beyond the physical boundaries of both Colleges.

1. Objectives of MoU

The objectives of MoU are:

- a) To promote and enhance academic interest between Dr. B.R.A. G.C. Dabwali and GCG, Kalanwali (Sirsa).
- b) To create means of cooperative efforts between the two institutes to effect academic collaboration through joint organization of Faculty Development Programs, Workshops, Training Sessions and other academic activities for both students and teachers.

- c) To promote research work among teachers and explore the possibilities of supervision/co-supervision of joint research studies.
- d) Upgrading faculty of both colleges with new teaching tools.
- e) Sharing techniques and expertise for improving the quality of Education.
- f) To share infrastructure like Library, Laboratories and Play grounds etc. as per availability and consent of the party whose facilities are proposed to be used by the other party.

2. Technical areas of collaborations

- a) Provide academic interaction by delivering Special Lectures on topics of relevance to the inter-disciplinary research and literary studies at both institutes.
- b) Usage of research and academic infrastructure for students, staff and faculty members of both institutes.

3. Proposed mode of collaborations

Dr. B.R.A. G.C. Dabwali and GCG, Kalanwali (Sirsa) propose to collaborate through the following:

- a) Cooperation and promotion of research, education and training in areas of mutual interest.
- b) Any other appropriate mode of interaction agreed upon between Dr. B.R.A. G.C. Dabwali and GCG, Kalanwali (Sirsa). A specific plan will be worked out by both the institutes depending upon availability of resources.

4. Terms and conditions

- a) The cost of development of infrastructure should be borne by the concerned institute.
- b) For education and research, the financial arrangements will be made on the basis of mutually agreed terms by both institutes.
- c) Usage of academic infrastructure of Dr. B.R.A. G.C. Dabwali and GCG, Kalanwali (Sirsa) can be allowed for limited period only subject to its availability.
- d) Both institutes agree to help, identify and invite the faculty members and students from the other institutes to participate in conferences, workshops and short-term courses.
- e) Both institutes can modify/delete/add any field of cooperation not mentioned in this MoU by mutual consent at any time in future.

Duration of MoU:

The duration of this MoU shall be for a period of five years from the effective date.

Confidentiality:

Each party agrees that it shall not, at any time, during or after executing the activities of this MoU, disclose any information in relation to these activities or the affairs of mentorship program without the express consent of other party. Any sensitive topics that are discussed will be held in the highest confidence.
